COMMUNITY USE OF GROUNDS

Kelsey Recreation Commission (KRC) and the Kelsey School Division (KSD) have agreed to a reciprocal joint-use agreement with the general objective of parity of services provided. Provisions affecting the Kelsey School Division and appropriate schools are as follows.

1. **Winton Pool**

KSD groups will be provided with a special rental rate per hour for school programming including a reduced facility fee for the KSD rentals. KRC will compensate KSD for providing security when the MBCI cafeteria is utilized for pool rentals.

2. **Roy H Johnston Arena**

KRC will provide to KSD, for school programming, use of the arena at no charge from 9:00 am – 4:00 pm on school days during the ice season when ice time is available. During the non-ice season, KSD will be provided use of the Arena for agreed hours, provided the concrete floor area is available.

3. **Community Programming - School Facility Use**

KSD will provide, at no charge to the KRC, school facilities (e.g. gymnasiums) for after hour KRC community recreational programming.

4. **Sportsplex Grounds**

- a) KSD, during regular school hours, will have priority use of the ball diamond(s), soccer pitches, skate park, tennis court and running track for instructional purposes.
- b) During and after hours school events must be coordinated with the Recreation Director to avoid scheduling conflicts and ensure that maintenance and preparation have been completed on the required facilities. KSD schools utilizing the Sportsplex grounds shall provide as early as possible a schedule of school uses planned, and notify the Recreation Director as soon as possible when cancellations or changes are required.

- c) Use of the sportsplex grounds by the community may occur during and after school hours providing the fields have not been booked by KSD. Fields and activities not booked by KSD may be used by the community during school hours as long as the user is not disturbing KSD teaching activities and is acting in accordance with School Division policies.
 - d) All School Division policies and school procedures will apply between the hours of 9:00 am - 4:00 pm (including arrival & departure times of students) on regularly scheduled school days. Supervision of School Division policies and procedures will be the responsibility of KSD. Should issues develop in the sportsplex area, KSD will notify KRC as soon as possible.
 - e) All bookings for the use of the sportsplex grounds will be coordinated through KRC. It is important that effective communication be obtained to ensure that the needs of KRC and KSD are known by both parties well in advance of the activities taking place.
5. **Wellness Centre**
Use of the Wellness Centre by the KSD is permitted if the court floor, track, or requested spaces are available. KSD will be required to book space and pay the current facility rental fees. Booking arrangements need to be made with the Recreation Director or Assistant.
